All vendors are asked to stay open until 8:00 on Friday p.m. You may remain open later.

(Vendors cannot move vehicles into the event area until spectators have left)

**Check In:** Thursday, July 21, 2:00 – 6:00 p.m.; Friday, July 22, 8:00 – 10:00 a.m.

**Waiver:**

The Committee reserves the right to reject any application. If your application is not accepted, your money will be refunded. No refund of the application fee will be made once you have been accepted for the WNC BBQ Event. You will be notified either by e-mail or USPS mail at least 30 days prior to the event. Any photo taken of your booth onsite and your responses to questions in the application become the property of the Maggie Valley Chamber of Commerce and may be used for promotional purposes. Vendors agree to identify and hold the Maggie Valley Chamber of Commerce and its employees, volunteers, and event sponsors harmless from any and all claims made against the WNC BBQ Festival including, without limitation, all costs, liabilities, judgments, expenses, damages or loss, or reasonable attorney's fees, arising out of or in omission to act of any structure erected by vendor, (II) any apparatus, equipment, or personal property used by the vendor.

**Agreement:**

I agree to maintain my vending area at the WNC BBQ Festival from Noon – 8:00 p.m. on Friday, July 24, 2015 and 10:00 am. – 6:00 p.m. on Saturday, July 25, 2015. Vendors are allowed to stay open later if desired. No vehicles will be allowed in the festival area until close of the event and spectators are at a minimum. I agree to remove trash from my vendor area and vacate the Maggie Valley Festival Ground no later than Noon on Sunday, July 26, 2015. No overnight camping is NOT allowed for Arts & Crafts vendors.
